LITTLE ACES

½ Hour - **\$495 per child** - Held on a modified court. No more than 3 students to a group. Students will learn age-appropriate skills. (Age 4-5 **must** be 4 prior to start of program)

RED 1

½ Hour - **\$495 per child** - Held on a modified court using progression balls for greater success. All groups have a 4 to 1 student to instructor ratio. (Age 5 **must** be in kindergarten prior to start of program)

RED ELITE

1 Hour - **\$750 per child** - Held on a modified court using progression balls for greater success. All groups have a 4 to 1 student to instructor ratio. (Ages 5-8; based upon experience)
